**SHORT TENDER NOTICE NO 07/2025**

Sealed tenders on prescribed Bill of Quantity are invited by the undersigned from the working contractor of the University/Registered contractor of the Govt. departments of appropriate class and category having sufficient experience in execution of similar nature of works, for the work mentioned below which will be received up to 3 P.M. on **29.07.2025** and will be opened on the same day in presence of the tendered or their authorized agents at 3.30 P.M.

**Terms and Conditions**

- (1) Tender papers will be issued only to eligible contractors on production of original and submission of self attested copies of : (a) Certificate of Registration. (b) GST Registration/Clearance Certificate.
- (2) No tender papers will be issued to those contractors, who have not completed the allotted work in time or are black listed by any works department or have not started the work after execution of Agreement. Self attested Affidavit in this regard is required to be enclosed with the application for issuing B.O.Q.
- (3) Execution of Agreement would have to be done within a week of allotment of work or the allotment of work would be cancelled and work may be allotted to 2nd lowest tenderer.
- (4) The Contractor will not apply for more than one work.
- (5) Earnest Money of the unsuccessful tenderer would not be refunded till execution of Agreement by the successful tenderer.
- (6) Payment would be made only after deduction of I.T., GST, Cess, Mining Royalty etc. as applicable and on availability of fund.
- (7) Estimated cost and quantity of Bill of Quantity may increase or decrease.
- (8) The Bill of Quantity can be obtained from the office of the Executive Engineer on any working day up to 1 P.M. on or before the **28.07.2025** on payment of the cost of Bill of Quantity (Non-refundable) in cash deposited by Bank Challan in State Bank of India, B.U. Campus Branch, Muzaffarpur. Account payee draft on any Nationalized Bank at Muzaffarpur in favour of the Registrar, B.R.A.Bihar University, Muzaffarpur will also be accepted.
- (9) The tender form must accompany the Earnest Money in shape of Bank Challan deposited in the S.B.I., B.U. Campus Branch, Muzaffarpur/ Postal Pass Book/N.S.C. duly pledged in favor of the Registrar, B.R.A. Bihar University, Muzaffarpur. secretariat
- (10) The contractor has to submit self attested copy of :  
  - (a) Certificate of Registration
  - (b) GST Registration/Clearance Certificate, G.S.T. Return if any.
  - (c) Copy of I.T. PAN Card, I.T. Return if any.
  - (d) Existing commitment.
  - (e) Self attested Affidavit ( Performa attached )
- (11) The undersigned reserves the right to reject any all tenders without assigning any reason whatsoever.
- (12) The works have to be completed in time schedule otherwise University will be free to take any action in this regard.
- (13) Other terms and conditions can be had from the office of the Executive Engineer during office hours on any working day but one day before the date of opening of the tender.
- (14) All the papers must be self attested.
- (15) B.O.Q. will not issue to those contractor already allotted the work order or being the 1<sup>st</sup> lowest or not executed the agreement.
- (16) Only those eligible contractors will apply who has class IV certificate
